POLL RESULTS OF THE EXTRAORDINARY GENERAL MEETING HELD ON 31 JANUARY 2022

References are made to the notice of extraordinary general meeting dated 15 January 2022 (the "EGM Notice") and the circular dated 15 January 2022 (the "Circular") of Rizhao Port Jurong Co., Ltd. (the "Company"). Unless the context otherwise requires, capitalised terms used herein shall have the same meanings as those defined in the EGM Notice and the Circular.

Accordingly, the total number of Shares entitling the Shareholders to attend and vote for or against all the resolutions proposed at the EGM was 820,000,000 Shares.
